Re: Introduction of Voluntary Travel Insurance Plan – Effective September 1, 2008.

The CPCO has arranged to make the MEDOC® Travel Insurance Plan available to all CPCO members and Family & Friends. It is an emergency medical insurance plan that offers CPCO members comprehensive coverage at competitive rates. The plan is administered by Johnson Inc. and underwritten by Royal & Sun Alliance Insurance Company of Canada.
